Commissioner Pruyn moved to approve the Minutes of the November 15, 2018 Meeting of the DuPage Water Commission. Seconded by Commissioner Russo and unanimously approved by a Voice Vote.

TREASURER'S REPORT

Treasurer Fates presented the November 2018 Treasurer's Report consisting of 12 pages, noting that pages 1 and 2 contained a brief summary of the report.

Treasurer Fates pointed out the \$172.4 million of cash and investments on page 4, which reflected a decrease of about \$0.6 million from the previous month. Treasurer Fates also pointed out the schedule of investments on pages 5 through 10 totaling \$152.3 million and the market yield on the total portfolio showed 1.92% which reflected an increase from the prior month. On page 11, the statement of cash flows showed a decrease in cash and investments by about \$2.2 million and operating activities generated \$6.9 million, and roughly \$113,000 of sales tax was received. On page 12, the monthly cash/operating report showed that the Commission had met or exceeded all of its reserve requirements.

Commissioner Russo moved to accept the November 2018 Treasurer's Report. Seconded by Commissioner Saverino and unanimously approved by a Voice Vote.

Commissioner Suess reported that the Finance Committee had reviewed and approved all finance reports with no actions items for Board consideration. Commissioner Suess then referred to page 1 of the Financial Report specifically highlighting the Commission's year-to-date revenues which were about 104% of the current budget and expenses were about 99% of the current budget noting the favorable margin of about \$5M to \$6M where the Commission's revenues exceeded its expenses.

TREASURER'S REPORT - December 31, 2018

I am pleased to report that I have reviewed and approved all journal entries and bank reconciliations for the month of December. I have also reviewed the monthly financial statements and budget status reports, and found them to be in order.

Summary of Cash & Investments (Page 4)

- Cash and investments totaled \$172.7 million at December 31st, an increase of \$0.3 million compared to the previous month. Cash inflows from operating and investment activities were offset by cash outflows related to the Bartlett project.
- 2. The balance in the BMO Harris checking account was \$20.2 million at December 31st, fairly flat compared to the \$20.1 million reported last month.
- 3. The BMO Harris money market accounts had \$12.4 million at month-end, relatively unchanged from the prior month balance.
- 4. During the month of December, the IIIT money market accounts decreased by approximately \$2.6 million from the prior month.
- 5. In December, our holdings of U.S. Treasury investments, Municipal Bonds, and Asset Backed Securitizations increased by \$2.4 million, \$1.1 million and \$2.0 million, respectively. In addition, U.S. Agency investments decreased by \$2.7 million.
- 6. The current holdings of cash and investments are in compliance with the approved investment policy.
- 7. For the eight months ended December 31, 2018, the Commission's cash and investments decreased a total of \$1.9 million.
 - The Operating & Maintenance Account decreased by \$1.1 for an ending balance of \$32.6 million.
 - The General Account increased by \$7.2 million for an ending balance of \$13.6 million.
 - The Sales Tax Account remained unchanged at \$283.
 - The Capital Reserve Fund decreased by \$8.8 million for a balance of \$42.9 million. The
 decline is due to the transfer of funds to pay for expenses related to the Bartlett project.

- The Operating Reserve Account increased \$0.6 million for a balance of \$68.7 million.
- The Long-Term Capital Reserve Account increased by \$0.2 million for a balance of \$14.9 million.

Schedule of Investments (Pages 5-10)

- 1. The average yield to maturity on the Commission's investments was 2.0%, an increase from the prior month average yield to maturity of 1.92%.
- 2. The portfolio ended the month of December 2018 with \$1.4 million of unrealized losses, compared to \$2.8 million in unrealized losses at April 30, 2018.
- 3. The amortized cost of our investments was \$152.5 million at December 31st.

Statement of Cash Flows (Page 11)

- 1. The statement of cash flows shows a breakdown of the \$1.9 million decrease in cash and investments for the fiscal year.
- Operating activities generated \$8.0 million as of the end of December 2018.
- 3. Approximately \$113,000 of sales tax revenue was received.
- 4. Loans Receivable, primarily related to Bartlett activity, increased by approximately \$10.8 million.
- Capital Assets purchased were \$866,000.
- 6. Cash flow from investment activity generated \$1.7 million of income.

Reserve Analysis (Page 12)

- The reserve analysis report shows the commission has met or exceeded all recommended reserve balances at December 31st. The Commission continues to adjust reserves targeted and transfer funds from the Capital Reserve account as the Bartlett project proceeds.
- 2. The Operating and Maintenance Account was \$32.6 million which is a balance currently sufficient enough to cover an estimated 89 days of normal operation and maintenance costs.
- 3. The Operating Reserve account was \$68.7 million which is approximately 188 days, this amount meets the minimum balance per the reserve policy.

CONTRACTUAL AGREEMENT

This Agreement is made on the 1st day of January 2019, between JOHN J. MILLNER AND ASSOCIATES, INC. ("JJM") having its principal place of business, at 2700 International Drive, Suite 100, West Chicago, IL 60185 and DUPAGE WATER COMMISSION having its principal place of business at 600 E. Butterfield Rd., Elmhurst, IL 60126.

IN CONSIDERATION of DUPAGE WATER COMMISSION, retaining JJM, it is agreed as follows:

I. COMPENSATION AND TERMS

DUPAGE WATER COMMISSION retains JJM and JJM hereby agrees to represent DUPAGE WATER COMMISSION in the capacity of "consultant", before the Illinois General Assembly and the executive levels of state and local government.

The term of this Agreement is as follows:

JJM represents and warrants to DUPAGE WATER COMMISSION that it has the experience and ability to perform the services required by this Agreement; that they will perform said services, in a professional, competent and timely manner, as represented and suitable for the performance of the Agreement; and that they have the power to enter into and perform this Agreement; and that their performance of this Agreement shall not infringe upon or violate the rights of any third party or violate any federal, state and municipal laws. JJM further warrants that they have complied and will continue to comply with the Illinois Lobbyist Registration Act.

IJI, INDEPENDENT CONTRACTOR

JJM acknowledges that the services rendered under this Agreement shall be solely as an independent contractor. JJM shall not enter into any contract or commitment on behalf of DUPAGE WATER COMMISSION, JJM further acknowledges that they are not considered an affiliate or subsidiary of DUPAGE WATER COMMISSION, and are not entitled to any of DUPAGE WATER COMMISSION employment rights or benefits. It is expressly understood that this undertaking is not a joint venture.

IV. BUSINESS PRACTICES

JJM hereby represents and covenants that they:

-have no knowledge or information that any unlawful payments, disbursements, assignments or transfers of property of any type have been made, or promised to any governmental official or to any intermediary, broker or agent who shall in turn, directly or indirectly unlawfully pay, disburse, assign or transfer property to any governmental official, to unlawfully influence any act or decision of any governmental official;

-will take all reasonable steps to ensure that no unlawful payments, disbursements, assignments or transfers of property of any type be made to any governmental official, or to any inter-

mediary, broker or agent who shall in turn, directly or indirectly unlawfully pay, disburse, assign or transfer property to any governmental official, to unlawfully influence any act or decision of any governmental official.

V. CONFIDENTIALITY

JJM recognizes and acknowledges that this Agreement creates a confidential relationship between JJM and DUPAGE WATER COMMISSION and that information concerning DUPAGE WATER COMMISSION, or its operation, whether written or oral, is confidential in nature. All such information concerning DUPAGE WATER COMMISSION is hereinafter collectively referred to as "Confidential Information". JJM will not use, disclose to any third party, directly or indirectly, for its own benefit or the benefit of others, both during the term of the Agreement and subsequent to its termination, any Confidential Information which JJM may acquire or develop in connection with or as a result of the performance of this agreement. JJM further agrees to bind their employees and subcontractors to the terms and conditions of this Agreement.

VI. GRANT

JJM agrees that their work product produced in the performance of this Agreement shall remain the exclusive property of DUPAGE WATER COMMISSION, and that they will not sell, transfer, publish, disclose, display or otherwise make the work product available directly to third parties without DUPAGE WATER COMMISSION, prior written consent. Any rights granted to JJM under this Agreement shall not affect DUPAGE WATER COMMISSION, exclusive ownership of the work product.

VII. TERMINATION OF AGREEMENT
